



**February is World
 Understanding Month**

FIESTA TIME

February is the month of Love. But for the City of San Fernando La Union, February is Fiesta Time. So our Mayor, Mary Jane Ortega, in her regular radio spiels, entices visitors to come this month and experience the ‘magic.’

Fiesta time is really a time of ‘magic’ for many towns and cities in our country. The word, ‘fiesta’ most probably comes the Old French word, ‘feste’ which means ‘to give immense pleasure.’ This is also probably the origin of words like ‘feast’ and ‘festival.’ So during this periodic celebrations, people are treated to ‘immense pleasure’ in the form of abundant food, entertaining shows, music and dancing, sports events, trade fairs and carnivals. People are made to temporarily forget their problems by ‘assaulting’ their ‘senses’ with all sorts of ‘goodies.’ That is why some people consider ‘fiesta time’ a ‘bane’ rather than a ‘boon.’ If I’m not mistaken it was the late Senator Raul Manglapus who partly blamed our backwardness on our ‘Fiesta Mentality.’ We go hungry the whole year round and then suddenly we splurge our savings in a few weeks on ‘non-essentials!’ Other people, however, consider ‘fiestas’ a necessary outlet. If not for this periods of enforced ‘optimism’ our people would sink into deep depression and perhaps engage in orgies of violence. As far as I know, there are no ‘fiestas’ in Rwanda, where scores of ‘Tutsis’ and ‘Hutus’ were massacred or in Sudan where civil war has led to the deaths of two million citizens. At any rate, filing a Bill to ban ‘fiestas’ in our country is like filing a Bill to ban ‘typhoons!’

‘Fiestas’ are of course, part of our Spanish heritage. Before the Spaniards managed to ‘Christianize’ the country, many of our people were engaged in ‘ancestor worship.’ Statues representing ancestors or ‘anitos’ were kept in many households. The wily Spaniards facilitated the process of colonization by replacing the ‘anitos’ with statues of ‘saints.’ Of course, to this day the Roman Catholic Church, was

inherited from the Spaniards, denies that it is promoting idolatry by this practice. Statues of the saints are not to be worshipped but are set up as reminders of holy men and women whose lives prove that human beings can follow the example of Christ. And we can ask this saints, who are in heaven, to pray for us just like we can ask a living friend to pray for us. However, the fine line between ‘veneration’ of saints and ‘pagan idolatry’ is often crossed as shown in the movie ‘Tatarin’ based on Nick Joaquin’s ‘Summer Solstice.’

Our ‘Fiesta’ is in commemoration of St William the Hermit (St. Guillaume in French and San Guillermo in Spanish.), who died on February 10, 1157. He was a French soldier who led a life of dissipation before becoming a ‘penitent’ and spending the rest of his days praying and fasting. He was the patron saint of a sitio at the foothills of the Cordillera. The people of this sitio fled to San Fernando then known as Pindangan, from ‘pindang’ meaning dried fish, to escape marauding Igorot headhunters. They were later joined by people from the coastal sitio of San Vicente, who were fleeing from roving Moro pirates raiding their place. Pindangan, as it expanded, was renamed, not San Guillermo or San Vicente, but San Fernando in 1786, in honor of King Ferdinand of Spain. Even then, Politics, played a big role in naming places! Nevertheless, our ‘fiesta’ falls on February 9, the last day of the novena to St. William the Hermit.

For the Rotarians of the City of San Fernando, ‘Fiesta Time’ is not just the time that the Club President gets to kiss the reigning Miss San Fernando while the rest of the members ‘ogle’ in envy- although, admittedly, that was part of my motivation in accepting the Club Presidency during my time! Our Club is among the strongest NGO partners of the local government in making our place a truly vibrant community.

Part of the ‘magic’ of San Fernando during ‘Fiesta Time’ is the ‘magic’ of Rotary!

Vocational Service and Director for International Service) to include Director for Youth Service and Club Secretary as a part of the governing body of the Club


b. Sourcing out funds for completion of the Rotary Youth and Service Center and possible Inauguration and turn over to the Board of Trustees on July 1, 2003.

Subject: Summarized COL Approved Enactments and Resolution

Below are some of the approved resolutions and enactments:

Club Meetings:

01-04. To allow the Club Board to cancel up to four regular meetings in a year and allow the cancellation of not more three consecutive meetings.

01-16. To allow the cancellation of a regular meeting due to the death of a club member.

01-530 To allow regular meetings to be cancelled due to armed conflict.

Attendance:

01-26. To remove the automatic termination provisions for failing to attend 60% of regular meetings.

01-38. To allow attendance credit for a member who attends less than 60% of a regular meeting when the member is unexpectedly called away from a meeting. 300-185

01-39. To allow attendance credit for attending a club sponsored community event or meeting or a club board or service committee meeting. 374-124

01-76. To allow the club board to determine the conditions and circumstances under which a member's absence may be excused. 341-53

Club Administration:

01-111 To request the RI Board to consider proposing legislation to allow clubs to merge together. 398-88

01-125 To provide for a new club officer: Secretary- Elect 321-177

01-130 To clarify the procedures for appeals and arbitration within clubs. 355-127

Types of Membership

01-148 To reduce the types of membership in clubs to active and honorary while retaining the classification principle.

01-160 To allow for transfer of membership

01-186 To allow the implementation of pilot projects chartering Rotary Clubs based on new model.

01-187 To preclude clubs from limiting membership based on gender.

01-192 To request the RI Board to encourage clubs to have two genders.

01-202 To amend provisions pertaining to honorary membership.

01-203 To provide that no person shall simultaneously be a Rotarian and a Rotaractor.

01-207 To provide for termination of membership at the discretion of the club board for failure to pay dues in a timely manner.

Programs

01-230 To request the RI Board to consider encouraging clubs and districts to ensure continuity in their projects and programs.

01-231 To request the RI Board to consider opportunities to enhance the public awareness of ROTARY. To request the RI Board to consider enhancing the importance of vocational service initiatives as a top priority.

01-234 To request the RI Board to consider enacting formal requirements concerning the selection and orientation of Youth Exchange students.

01-240 To request the RI Board to consider encouraging clubs to establish Youthact Clubs for youth ages 11 to 14.

01-241 To request the RI Board to consider adding "Youth Service " as fifth avenue of Rotary Service.

01-243 To request the RI Board to consider adopting Rotary Youth Programs of Enrichment as an official program for New Generations

01-249 To request the RI Board to consider encouraging clubs to support projects for rehabilitation of polio-disabled children

01-254 To request the RI Board to encourage Rotarians to promote Preserve Planet Earth by planting and fostering plants.

01-266 To request the RI Board to consider initiating a program to commemorate the memory of Past President Arch Klump.

**My Job as District Chairman of Rotary Foundation**

My first acquaintance with ROTARY FOUNDATION was in 1977 when I became a Paul Harris Fellow. As required by Rotary International,

the District Chairman should preferably be a Past District Governor and a District Governor should submit to The Rotary Foundation, under the umbrella of the Rotary International, the names of the Chairman and members of the subcommittees under it such as GSE, Grants, PolioPlus, Alumni, Annual Giving, Scholarship and Permanent Fund six months before his term as Governor. The District Chairman supervises the chairmen of the subcommittees under it. The DRFC (District Rotary Foundation Chairman) plays a critical role in furthering the Rotary Foundation's objective of world understanding and peace by reaching out to the clubs sharing the foundation's important message and helping to realize the Foundation's goal.

To be effective as Chairman, the DRFC must have continuity of leadership, therefore, the DRFC should be appointed for at least a three year term. The DRFC must have a significant knowledge, commitment to, and experience with Rotary Foundation activities. The DRFC members should be appointed based on their commitment to The Rotary Foundation as demonstrated through program participation and financial contribution.

In 1987-88, during my term as Governor, I could hardly find one to be the DRFC, not even my closest PDG friend, because as PDG he knows the big responsibility. I appointed in name a PDG to be the chairman and I did the actual job, being aware that a current Governor cannot serve a DRFC at the same time.

The main thrust of Rotary then was to raise funds for Polio. I have worked and worked to

reach my goal set by R.I. in the amount of US \$ 95,150.00. I was able to raise US \$ 70,518.37 with pledges of US \$ 28,000.00 which I was to collect the following year after my term as Governor, being appointed as DRFC. I would have completed my goal if I had the capital to advance to R.I. the amount to cover up post-dated checks, but I didn't have it.

As I attended International Conventions and Zone Institutes, I became more knowledgeable of the workings of the Rotary Foundation. I have heard speeches to include recipients of the programs of Rotary Foundation and have seen tapes as well. All these have encouraged me to work more and more.

In Rotary Year 1995-1996 during the term of Gov. Nelson Yuchongtian, I was able to raise US \$ 98,000.00. I exerted all my time, effort and resources because I promised myself that was my last term as chairman. I had PHP 500,000.00 to advance postdated checks that were encashed six months after the term of Gov. Nelson.

I continued to work as Chairman up to this time for a total of thirteen (13) years excluding the three (3) years gap in between terms. But after this year, NEVER again as chairman. In my observation of 13 years, RF contributions are based on friendship and more importantly on dedication. We were able to convince presidents of different clubs to become Paul Harris Fellows and past presidents to honor their spouses making them PHFs and even their parents and children. Asking for contributions to RF should be personalized- the most effective way. Let's Sow the Seeds of Love thru RF and more BLESSINGS will come to us; helping people we don't know and will never meet. That's how I convinced Rotarians to share what God has given them.
